<u>Twinning selection procedures under ENPI:</u> <u>REMINDER for MS, NCPs, PAOs and Delegations</u>

• The Contracting Authority (the PAOs or the Delegation) when notifying the results of the selection to MS should, for successful MS, spell out its rights and responsibilities and, for the unsuccessful MS, give a summary of the strong and weak points of the proposal, in conformity with Annex C8, Evaluation grid for ENPI, point 5, Conclusion and recommendations.

• MS NCPs should send their Twinning proposals to the e-mail address mentioned in the message of circulation and not to (or copy to) DG Enlargement.
